Interested bidders may obtain non-transferable tender document by submitting non-returnable demand draft/cash of Rs. 1000/- separately for each site as detail A, B & C above in favour of “IWAI FUND” payable at Kolkata. Tender Documents will be available for sale from **05.03.2010 to 19.03.2010** between 1000 hours to 1700 hours (IST) on any working day from the office of Director, IWAI, P-78, Garden Reach Road, Kolkata - 700 043(WB).
5. Request for purchase of tender must be accompanied with documentary evidence of credentials including attested work done certificate, attested photocopies of work, Sales tax Registration certificate, Valid trade license, Valid labour license and valid license issued by the State Govt. for trade, similar work done, performance certificate etc. The tender shall meet the following pre-qualification criteria for considering his candidature for the work.
 - a. The tenderer should have a valid PAN no. in the name of agency shall submit copies of valid income-tax clearance certificates along with request for tender document. He should also attach copies of all certified copy of license in the particular field. He should also submit documentary evidence of GPF code number, EPF code Number, ESI code Number and service tax registration number. He should also submit at least three attested work done certificates of Govt. / PSU organizations executed during last 5 (five) years.
 - b. Documentary evidence on adequate financial resources.
 - c. Average annual turnover during last three years ending 31st March of the previous financial year, should be at least 4.32 lakhs, 3.53 lakhs & 1.20 lakhs for A, B & C location mentioned above. Experience of having successfully completed similar works of providing security services for last 3 years or having either of the following:
 - (a) Three similar works each costing not less than 40% of the estimated cost: **or**
 - (b) Two similar works each costing not less than 50% of the estimated cost: **or**
 - (c) One similar work completed not less than 80% of the estimated cost.
 - d. Latest certificate of solvency from nationalized / scheduled Bank included in the Second schedule of the RBI Act for not less than the value indicated below:
