**DESCRIPTION OF WORK : Salvaging work for Bangladeshi bulk cargo carrier M.V.NILAN sunk at 22°14'02" latitude and 088°04'48" longitude (approx) near hooghly river point adjacent to kopt shipping channel and appointment of a salvaging agency on annual retainership basis for undertaking salvage work in Indian side of the protocol route i.e. Raimongal to Namkhana of Sundarbans & Dhubri to Pandu in NW-II and in NW 1 between Haldia to Farakka**

Separate sealed Tenders are invited in two covers (Part - I Technical Bid & Part - II Price Bid) from reputed and registered agencies for the work as described above **Earnest Money Deposit for the above work is Rs. 2,00,000/-.**

1. Interested bidders may obtain non-transferable tender document by submitting non-returnable demand draft for Rs. 1000/- drawn in favour of "IWAI FUND" payable at KOLKATA. Tender Documents will be available for sale from **30.03.2010 to 16.04.2010 between 1000 hours to 1530 hours (IST)** on any working day from Monday to Saturday from the office of Director, Inland Waterways Authority of India, P-78, Garden Reach Road, Kolkata - 700 043(WB).
2. The tender document can also be downloaded from the IWAI's website "www.iwai.nic.in" Bidders submitting the downloaded version of tender document are required to submit Rs. 1,000/- (Rupees One thousand only) as the cost of tender document along with tender in the form of non refundable demand draft made in favour of 'IWAI FUND' payable at KOLKATA at any nationalized/schedule bank. A signed declaration stating that no alteration has been made in any form in the downloaded tender document is to be enclosed with the tender by the bidder for downloaded tenders.
3. The tenderer shall meet the following pre-qualification criteria :

- i. Tenderer shall have Permanent Account Number issued by Income Tax Deptt.
  - ii. Tenderer shall be registered with sales tax / trade tax department.
  - iii. Average annual financial turnover only for salvage work for sunken vessels / barges during last three years ending 31<sup>st</sup> March of the previous financial year, should be at least 25 lakhs. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one of which this tender invited should be either of following.
    - a) Three similar works each costing not less than Rs. 40.00 lakhs or
    - b) Two similar works each costing not less than Rs. 50.00 lakhs or
    - c) One similar work completed not less than Rs. 80.00 lakhs.
  - iv. Latest certificates of solvency from Nationalized / Scheduled bank including in the second schedule of the RBI Act for not less than the value indicated below .
  - v. Application of only such agencies shall be entertained who have successfully salvaged sunken vessels from major rivers, shipping channel in the ports of India or other country as well as in the sea and their contracts / agreements have not been prematurely terminated by the agency engaging them from such work due to failure to salvage / slow and unsatisfactory progress of work.
  - vi. The tenderer shall agree to the terms & conditions of the tender and return the tender duly signed in each page for agreeing the same.
  - vii. The tenderer shall submit required Earnest Money Deposit in the form of demand draft. Any / all submissions made without the earnest money and / or after the last date and time fixed for submission of the bids shall be deemed to be rejected.
  - viii. The preference shall be given to the bidder having specific experience salvage work in similar conditions.
4. The complete bid as per the tender documents should reach office of Director, IWAI, P-78 Garden Reach Road, Kolkata – 700 043 by 1500 hours on **17.04.2010** and will be opened on same day at 1530 hours.
