Tender document will be available for sale from 29-04-2010 to 10-05-2010 between 10.00 AM to 5.00 PM (IST) on any working day from Monday to Saturday from the office of the Director, IWAI at 5th Floor, Parameshwari Building, A.T Road Chatribari
2. The tenderer shall have to meet the following criteria to become eligible for issue of tender:-
 - i. The tenderer shall be registered with Central Public Works Department, Railways, MES and State PWD/ Irrigation Department or non-registered contractors having experience of working with IWAI.
 - ii. Tenderer shall have Permanent Account Number issued by Income Tax Deptt.
 - iii. The tenderer shall have a valid trade license and a vat certificate.
 - iv. The tenderer shall have to enclose job completion certificate issued by the client in respect of having undertaken similar works related to a port/river terminal or have undertaken modifications/repair works of jetties
 - v. The tenderer shall agree to the terms & conditions of the tender and return the tender duly signed in each page for agreeing the same.
